

# Detroit Environmental Agenda

How can we help advance Detroit's sustainability goals, together?

The Detroit Environmental Agenda (DEA) was initiated in early 2012 following an environmental summit held by the City of Detroit in 2011. Ten organizations came together and formed the DEA, whose purpose was to engage Detroit residents and groups about sustainability, public health, and environmental justice issues taking place in their city. The DEA surveyed nearly 500 residents and created Detroit's first grassroots sustainability action agenda describing the state of the environment in Detroit's neighborhoods, while also providing community-based solutions to respond to these problems. This report, named after the Coalition, was titled Detroit Environmental Agenda and was published in July of 2013.

## 2021 priorities

### community

- Increase community leadership and decision-making around blight control, as well as around ownership and redevelopment of vacant lots and buildings
- Development and publication of municipal election Voter Guides to inform and activate Detroit voters

### energy

- Improve air quality and strengthen climate resilience by helping increase the demand for clean energy alternatives, like solar power

### jobs

- Build a database connecting green job seekers and employers

### public health

- Help reinstate the Green & Healthy Homes program spearheaded by Wayne State University's Center for Urban Studies
- Improve public and environmental health in planning and zoning (buffer zones, truck routes, etc.)
- Create safe and reliable walking and biking pathways for residents of all ages and abilities that connect them with parks, schools, transit, jobs, retail, and more

### recycling

- Implement the citywide recycling program expansion approved by City Council
- Create and implement citywide food waste prevention, food recovery and rescue, as well as organics recycling programs

### water

- Protect and restore our local waterways
- Support water affordability and educate communities to monitor and interpret water quality
- Incorporate green stormwater infrastructure into street redesign and greenway projects
- Reduce industrial and stormwater pollution, through the Protecting Our Waters Ordinance

## major wins

The DEA and its members have been actively involved in leading and supporting efforts to make Detroit a greener and more just city for its residents. Here are notable examples of our collective wins over the years:

- Candidate and voter education on sustainability and environmental justice issues in Detroit since 2013
- Detroit's first curbside recycling program or single-family homes launched in 2015
- Detroit's first Office of Sustainability launched in 2017
- Detroit's first Climate Action Plan published in 2017
- Detroit's first Public Health Action Plan published in 2017
- Detroit's first Sustainability Action Agenda published in 2019
- Detroit's first municipal Sustainability Commission launched in 2019
- Detroit Renewable Power (Detroit's municipal waste incinerator) successfully shut down in March of 2019 after decades of advocacy
- Detroit's first Greenhouse Gas Ordinance passed by City Council in 2019 to reduce citywide carbon emissions by 30% by 2024
- Commercial Curbside Recycling Expansion to multifamily buildings, public spaces, businesses, municipal buildings, churches, successfully approved by City Council in 2019
